TIMELINE

Step 1:

Onboarding the client by signing Retainer Agreement .

Step 2:

Passport copy, Police Clearance Certificate showing clear criminal record and CV sent to Vanuatu for pre-screening. At that stage client needs to cover the Financial Intelligence Unit check with the necessary government fee for the due diligence process.

Step 3:

Within 10 days investor will receive written confirmation of clearance to proceed and make the full payment along with the remaining documentation filling.

Step 4:

Complete application submit for screening.

The Vanuatu Citizen Commission will examine your application and check that all stipulated documentation and payment has been received.

Step 5:

Confirmation by the Prime minister. Next the President will personally sign the Citizenship Certificate.

Step 6:

Take oath and become a citizen.

The last step to be taken is to take citizenship oath. This is a ceremony where you pledge your allegiance to Vanuatu and in return become a full citizen of the country with all the associated rights.

At this stage client will receive his Citizenship Certificate and the new Passport.

No need physically to be present in Vanuatu to take the oath. The ceremony can be arranged at the nearest Vanuatu Embassy or VIP service of official government traveling to your country of residence to be arrange upon payment of additional fee.
